7. Bids must be accompanied by cost of Tender document in form of DD as specified and drawn in favour of **Director Finance, JDA, Vikas Bhawan Rail Head Complex, Jammu** and Bid security (EMD) & Performance Security, if any in form of CDR / FDR payable in favour of **Superintending Engineer, Jammu Development Authority, Vikas Bhawan, Rail Head Complex, Jammu.**

The original documents in respect of cost of Tender Document, EMD and other relevant documents must be delivered in the Office of **Superintending Engineer, JDA Vikas BHawan, Rail Head Complex, Jammu** on or before **23-01-2017 (1400 Hours)** to either **Sh.Madan Lal, PA to S.E. JDA (Mob.No.8803514007)** OR **Sh.Pawan Kumar (H.D.), JDA (Mob.No.9086007298)**. The Department shall not be responsible for any delay, what so ever.

The Technical Bids and Financial Bids will be opened online in the office of **Superintending Engineer, JDA Vikas BHawan, Rail Head Complex, Jammu.**

If the office happens to be closed on the date of opening of the bids as specified, the bids will be opened on the next working day at the same time and venue.


8. The bid for the work shall remain open for acceptance for a period of **90 days** from the last date of submission of bids. If any bidder/tenderer withdraws his bid/tender before the said period or makes any modifications in the terms and conditions of the bid, the said earnest money shall stand forfeited.
9. No Engineer of Gazetted rank or other Gazetted Officer employed in Engineering or Administrative duties in an Engineering Department of the State Government is allowed to work as a Contractor for a period of two years after his retirement from Government service, without permission of the Government. This contract is liable to be cancelled if either the contractor or any of his employees is found any time to be such a person who had not obtained the permission of the Government as aforesaid before submission of the tender or engagement in the Contractor's Service.
10. Other details can be seen in the bidding documents.
11. The contractor should have adequate trained supervisory staff in his establishment.
12. The contractor shall conduct the entire requisite test as per the established engineering practices and codes and submit the test reports to the Engineer-in-Charge. All the tests shall be conducted by the contractor at his own cost.

13 **Instructions to bidders regarding e-tendering process.**

- a. The interested bidder can download the NIT/bidding document from the website <http://jktenders.gov.in>
 - b. To participate in bidding process, bidders have to get (DSC) "Digital Signature Certificate" as per Information Technology Act-2000, to participate in online bidding. This certificate will be required for digitally signing the bid. Bidders can get above mentioned digital certificate from any approved vendors. The Bidders, who already possess valid (DSC) Digital Signature Certificates, need not to procure new Digital Signature Certificate.
 - c. The bidders have to submit their bids online in electronic format with Digital Signature. The bids cannot be uploaded without Digital Signature. No Proposal will be accepted in physical form.
 - d. Bids will be opened online as per time schedule mentioned in Para 3(c).
 - e. **Before submission of online bids, bidders must ensure that scanned copies of all the necessary documents have been attached with the bid, failing which, their offer shall be rejected.**
 - f. The department will not be responsible for delay in online submission of bids whatsoever reasons may be.
 - g. All the required information for bid must be filled and submitted online.
 - h. Bidders should get ready with the scanned copies of cost of documents & EMD as specified in the tender documents. The original instruments in respect of cost of documents, EMD and relevant documents are submitted to the Tender Inviting Authority prior to the opening of the tender. The Department shall not be responsible for any delay.
 - i. The details of instruments viz:- cost of Tender document and EMD as specified in the tender document should be the same as submitted online (scanned copies) and submitted in original, otherwise, bid will be rejected as Non-responsive.
 - j. Bidders can contact the undersigned for any guidance for getting DSC or any other relevant details in respect of e-tendering process.

15. The specifications for execution of works shall conform to the provisions of relevant clauses of Engineering codes/ specifications.
16. The Building shall be Structurally Designed and duly vetted by the DIQC Department, Jammu.
17. Quantity can be increase or decrease by 25% of the advertised quantities.
18. Any item executed beyond the advertised items shall be paid as per sanctioned schedule of rates 2012 without any appreciation/Depreciation.
19. The structural design shall include the load bearing/bearing capacity test and other relevant test of construction site.
20. The Bidder shall conduct all material as well as cube tests and the result should be attested with the running account bill without which no payment shall be processed.
